Can No1 CopperPot change the interest rate?	No, the interest rate is fixed for the life of the loan. Interest accrues daily and is charged monthly.
How do I open and manage my account?	Loans can be applied for on the website, on the app, face to face or over the telephone. You can manage your account via telephone, email, or the members area.

Repayment information	You can repay your loan by payroll deduction or Direct Debit. When you apply for a loan, we'll tell you how much your repayments will be. It also includes any interest charged. We'll start taking the payments the month after you apply. To see the cost of your monthly repayments prior to application please use the loan calculator provided on the link under interest rates. As we do not use representa- tive APR this will show the actual interest rate you will be charged if you are approved. Please be aware that if approved the repayment amount on your loan agreement may differ slightly from the loan calculator depending on the date your loan is approved and the selected repayment date.
